Bid must be accompanied by a BIDDER'S BOND in the form of CASH or MANAGER'S CHECK in the amount equal to **2% of the BID PRICE**. No other form of bid bond will be accepted. The bidder's bond is to be enclosed in the sealed envelope containing the bid.

Prospective bidders are to attend the schedule of the Pre-Bidding Conference to be held in the SURSECO-I Main Office, San Fernando, Bislig City. All bids and other documents shall be submitted in a **sealed envelope** addressed to the Chairman, Bids & Awards Committee, SURSECO-I, and shall be submitted on or before the Opening of Bids. The bids, together with the required documents, shall be opened on the schedule of the Opening of Bids. The same shall be held at the SURSECO-I Main Office, San Fernando, Bislig City.
